INITIAL SUBSCRIPTION(S) WILL NEED TO BE PAID IN FULL BY CHEQUE OR CREDIT CARD AND ATTACHED TO THE MEMBERSHIP APPLICATION FORM(S).

Automated Subscription Renewals for Business Membership

We have available Automated Payment Plans for those who want to maintain their membership on that basis. All you have to do is choose which payment plan suits you.

You can pay your renewal of annual business subscriptions, annually or by way of instalments half yearly or quarterly. The automated payment plan option is only available via the Direct Debit payment plan. You can use this plan to automatically maintain and / or to renew your membership, while easily managing your cash flow. This way you can let us do the hard work for you.

Important - Conditions of Membership with the Payment Plan

If you choose either the half yearly or quarterly payment plan you shall be deemed to have accepted the terms and conditions of the Association's annual membership subscription and shall be liable for the payment of that full annual subscription. Should you resign from the Association within that 12-month period you shall be liable for the unpaid portion of the subscription.

General Information

In order to maintain your business membership you must maintain your Gold Card membership. In other words if you cancel your Gold Card Membership your Business membership will automatically be cancelled. However if you cancel your Business membership due to your circumstances changing, you are still able to retain your Gold Card membership.

As the holder of the Gold Card you **cannot** promote yourself as a Certified Builder. The Gold Card can only be used to identify the holder of that card as being trade qualified. If you are invoicing your services to the general public it shall be deemed that you are operating a business. Under the Rules of the Association you must then apply for Business Membership. If you choose not to apply for Business Membership your Gold Card membership **can** be denied particularly if in the Associations view that granting such membership the Gold Card might be open to misuse or misrepresentation. If you invoice your service predominately to a Certified Builder (a Business member of the Association) you will be exempt from this requirement to seek business membership unless you choose to do so.

House Inspections. CBANZ® will no longer permit the use of its name or logo to be used in association with any house inspections.

If you are the Owner/Director of the business and you are not a Gold Card Member and do not qualify to become a Gold Card member but you employ a person who is trade qualified and is eligible to become a Gold Card member as a Construction Manager either on a wage or salary, your business can become a business member. (This Construction Manager cannot be on contract). **Important Note:** You will be required to enter into a written contractual undertaking that you will maintain the employment of "Gold Card Member" in a Construction Management position. Should you loose or dispense with the services of that person you will have thirty days in which to replace that person who again must meet the Gold Card Membership criteria in order to maintain your business membership. Otherwise your business membership will be **suspended**.

ADVERTISING LEVY – Business Membership

The Advertising Levy is paid by every Business member on the 1st of July each year. Should you join at any time other than July you will be invoiced upon your membership being approved at a prorated amount.
